- ❖ **EUROPEAN PUBLIC PROSECUTOR'S OFFICE Consolidated annual activity report Financial year 2021**
- ❖ **First experiment/attempt of understanding a body of the European Union through the Virtual reality, in this case it is a game which is technically called “serious game” which entrusts the gamer of experiencing the reality: in this case it will bring the person closer to the “perspective” of the EPPO**
- ❖ **Copernican Revolution** in the use of the Virtual Reality (VR)
- ❖ **Proud to announce that there will be a piloting High-School of Milan – Istituto Ernesto Breda – Liceo Scientifico - which will participate to the game, but this will be extended to many more, reaching the number of about 200 students:**
- ❖ **The students will have a frontal lesson and then will put into practice what they have learned with the use of the serious game.**

- Technical Instruments OCULOS for the VR will be used: It is the translation from **the EPPO Directive - 2017/1939 of 12 October 2017** to a practical realization of it.



PROCESS OF TRANSLATION



- **2019:** The first European Chief Prosecutor, Laura Kövesi, is appointed by the Council on 14 October 2019. Her appointment is confirmed by the European Parliament a few days later.
- **2020:** The Council appoints 22 European Prosecutors, one for each of the participating EU Member States, on 27 July 2020. The European Prosecutors and the European Chief Prosecutor give solemn oath before the Court of Justice of the EU on 28 September 2020.
- **2021:** The EPPO starts operations on 1 June 2021, after the European Commission officially confirms the starting date on 26 May 2021.
- **2022:** The EPPO issues its first annual report.
